## 4. First Aid Measures

Inhalation

IF INHALED: remove person to fresh air and keep comfortable for breathing. Immediately call a POISON CENTRE or doctor.

Eye Contact

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTRE or doctor.

Swallowed

IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Immediately call a poison centre or doctor. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs. Never give anything by mouth if person is unconscious, or is convulsing.

Skin Contact

IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water. Immediately call a poison centre or doctor. Wash contaminated clothing before reuse.

Most important symptoms and effects, both acute and delayed

Inhalation of vapour can cause respiratory tract irritation or chemical burns. Burning pain and severe corrosive skin damage. Symptoms may include redness, oedema, drying, defatting and cracking of the skin. Causes serious eye damage. Symptoms may include stinging, tearing, redness, swelling, and blurred vision. Permanent eye damage including blindness could result. Harmful if swallowed. Causes chemical burns to mouth, throat and stomach.

Indication of any immediate medical attention and special treatment needed

Provide general supportive measures and treat symptomatically. Chemical burns: Flush with water immediately. While flushing, remove clothes which do not adhere to affected area. Call an ambulance. Continue flushing during transport to hospital. Keep victim under observation. Symptoms may be delayed.

Personal precautions, protective equipment and emergency procedures

Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Wear appropriate protective equipment and clothing during clean-up. Do not breathe mist or vapour. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing.

Methods and material for containment and cleaning up

Ensure adequate ventilation. Local authorities should be advised if significant spillages cannot be contained. For personal protection, see section 8 of the SDS.

This material is classified as a water pollutant under the Clean Water Act and should be prevented from contaminating soil or from entering sewage and drainage systems which lead to waterways.

Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb spillage to prevent material damage. Use a non-combustible material like vermiculite, sand or earth to

soak up the product and place into a container for later disposal.

Following product recovery, flush area with water.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.
